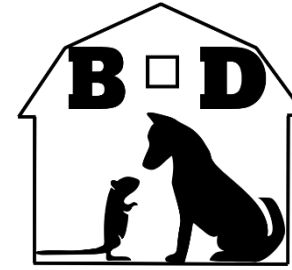

Run Order

Dynamo Dogsports reserves the right to change the run order based on entries and will send final class run order and judging schedule confirmation prior to the start of the trial. Dogs will be run in height order. Dogs being handled by the same person must be separated into different staged groups.

Due to Covid constraints there will be NO benching in the building.

In each class competitors will be give a time to enter the building for the Briefing, a time to enter for their Handler Retreat, and a time to enter for their run.

Competitors are ONLY allowed in the building during their scheduled time (or to use the washrooms)

Masks must be worn at all times when not competing, and 10' distance maintained where-ever possible.

Move-ups

If your dog earns a TITLE in Novice you can move to Merit on the same day. Just let the Scoring person know within 15 minutes of the end of the Novice class, so they can add your entry to the Merit lineup, as it may make a difference to handler retreats.

Awards

Qualifying ribbons will be awarded for all qualifiers in TITLING and GAMES classes, including PRE-NOVICE.

Placement ribbons will be awarded for 1st through 3rd in all classes except PRE-NOVICE.

New title ribbons Rosettes will also be awarded to anyone who earns a NOVICE BARN DOG TITLE.

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of Barn Dog Association, including but not limited to the following:

This event is held under Barn Dog Association Rules and Regulations and is open to all dogs being at least 6 months of age, pure breed or mixed breed, except aggressive dogs.

No leads, food, toys or any other aids or devices shall be permitted on the course at any time.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and / or children. Any exhibitor whose dogs and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may be asked to leave the show grounds and no refund of fees shall be given.

All dogs must be penned, crated or on leash when not in the ring. All dogs must be under control when exiting the ring. Any dog engaging in aggressive or out of control behavior upon exit of the ring may be disqualified and / or required to leave the show grounds and no refund of fees shall be given.

Exhibitors MUST keep crate and exercise areas clean. Please clean up after yourselves and your dogs. Anyone who does not clean up after themselves or their dogs may be required to leave the show grounds and no refund will be given.

There will be no refunds after the closing date, except for injured dogs, and only providing the trial secretary is informed prior to the trial date and a certificate from a veterinarian is provided.

Females in Season are permitted to run, but will be run last in the running order. They MUST wear some sort of garment to ensure that they do not drip on the course, and are expected to crate and potty somewhere away from the other dogs. Other dog owners will also be made aware of the females condition so that they can minimize the chance that their dogs will be distracted.

Entry fees must list the Dogs Barn Dog Registration number OR be accompanied by a Barn Dog Registration Application and appropriate fee.

All dogs on the trial grounds must be on a leash at all times when not in the ring. No flexi-leashes allowed.

No smoking is allowed anywhere on the trial grounds.

REGISTERING DOGS WITH THE BARN DOG ASSOCIATION OF CANADA

A requirement to competing in Barn Dog Official events is that the dog must be registered with the sanctioning organization before the results for the event are submitted to the Barn Dog Association.

IF YOUR DOG HAS NOT BEEN REGISTERED PRIOR TO ENTERING AN OFFICIAL EVENT, YOU MUST COMPLETE THE REGISTRATION FORM AND SUBMIT WITH YOUR REGISTRATION FEE, ALONG WITH THE ENTRY FORM.

Your entry is not valid unless this Agreement is signed, dated and submitted with the correct fee.

In consideration of the acceptance of this entry by the Barn Dog Association of Canada and Dynamo Dogsports, and the opportunity to have my Dog participate, compete in and/or be judged at this Trial, I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.

2. I agree that Barn Dog Association of Canada, and/or the Dynamo Dogsports may refuse my entry for any reason that are deemed to be sufficient by those entities

3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests, damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue the Barn Dog Association of Canada, Dynamo Dogsports or any of the directors, executives, committees, representatives, employees, volunteers or agents of either the Barn Dog Association of Canada or Dynamo Dogsports ("the Personnel"), for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.

4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event.
